EMERGENCY ORDER

(COVID-19 Public Health Emergency)

WHEREAS, on March 1, 2020, Governor of Florida RON DESANTIS issued Executive Order number 20-51 directing the Florida State Health Officer and Surgeon General to declare a Public Health Emergency for COVID-19; and

WHEREAS, on March 1, 2020, the State Surgeon General and State Health Officer declared a Public Health Emergency exists in the State of Florida as a result of COVID-19; and

WHEREAS, on March 9, 2020, Governor DeSantis issued Executive Order 20-52 declaring a state of emergency in the State of Florida due to the immediate danger to the public health, safety and welfare created by COVID-19; and

WHEREAS, Florida has experienced positive cases for COVID-19; and

WHEREAS, on March 11, 2020, the World Health Organization declared COVID-19 a pandemic; and

WHEREAS, on March 13, 2020, President Donald J. Trump has declared a national emergency related to the COVID-19 crisis; and

WHEREAS, the CDC currently recommends community preparedness and everyday prevention measures be taken by all individuals and families in the United States, including voluntary home isolation when individuals are sick with respiratory symptoms, covering coughs and sneezes

with a tissue and disposal of the tissue immediately thereafter, washing hands often with soap and water for at least 20 seconds, using of alcohol-based hand sanitizers with 60%-95% alcohol if soap and water are not readily available and routinely cleaning frequently touched surfaces and objects to increase community resilience and readiness for responding to an outbreak; and

WHEREAS, the CDC currently recommends mitigation measures for communities experiencing an outbreak including staying at home when sick, keeping away from others who are sick, limiting face-to-face contact with others as much as possible, consulting with your healthcare provider if individuals or members of a household are at high risk for COVID-19 complications, wearing a facemask if advised to do so by a healthcare provider or by a public health official, staying home when a household member is sick with respiratory disease symptoms if instructed to do so by public health officials or a health care provider; and

WHEREAS, as Secretary of the Department of Children and Families (Department), I am responsible for meeting the dangers presented to this agency and the people we serve by this emergency.

NOW, THEREFORE, I, CHAD POPPELL, as Secretary of the Department, by virtue of the authority vested in me by section 20.19, Florida Statutes, and Executive Orders 20-51 and 20-52 issued by Governor DeSantis, and all other applicable laws, promulgate the following Emergency Order to take immediate effect:

<u>Section 1</u>. In exercising my authority as Secretary of the Department, and only to the extent necessary to respond to this emergency, I hereby:

A. Suspend section 916.107(1)(a), Florida Statutes, for the purpose of suspending the 15day deadline for the transfer of forensic clients to a civil or forensic facility. This suspension is necessary to accommodate 14-day quarantine policies enforced within detention facilities to allow for the incubation period associated with COVID-19.

B. Suspend section 916.107(3)(a)(1), Florida Statutes, for the purpose of suspending the 48-hour time period physicians are permitted to provide emergency treatment to clients, without consent, to allow for continued treatment for conditions and/or symptoms related to COVID-19, as necessary to combat the limited access to courts and lack of ability to modify court orders.

C. Suspend section 402.305(2)(e), Florida Statutes, for the purpose of promoting flexibility and allowing for alternative educational and testing methods for child care personnel, where COVID-19 has prevented access to same.

Section 2. The Department shall review its use of State buildings and facilities and may close such buildings and facilities in those portions of the State affected by this emergency, to the extent necessary to meet this emergency. Further, the Department shall report the closure of any State building or facility to the Department of Management Services.

<u>Section 3</u>. This Emergency Order and other final actions in response to this emergency shall be provided to the State Coordinating Officer contemporaneously or as soon as practicable.

Section 4. In accordance with Executive Order 20-52 issued by Governor DeSantis, this Emergency Order shall expire upon the expiration of Executive Order 20-52, including any extensions thereto.
