

**Central Florida Cares Health System, Inc.
Amendment #2 to Contract No. LBC23**

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **LifeStream Behavioral Center, Inc.**, hereinafter referred to as the “Provider,” amends **Contract No. LBC23**.

The purpose of this amendment is to align the budget with the FY20-21 funding allocations as shown below:

- Adult Substance Abuse
 - \$136,726.37 recurring increase in MSSM2
 - \$2,202.48 recurring increase in MSSGP
 - \$59,769.66 recurring increase in MSSM3
- Children’s Mental Health
 - \$23,029.85 recurring decrease in MHC71
