

**Central Florida Cares Health System, Inc.
Amendment #6 to Contract No. PPB22**

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **Osceola Mental Health, Inc. d/b/a Park Place Behavioral Health Care Inc.**, hereinafter referred to as the “Provider,” amends **Contract No. PPB22**.

The purpose of this amendment is to align funding with the FY21-22 budget and update the Subcontract, Exhibit A, Exhibit B, Exhibit C, and Exhibit D to align with contractual requirements. A breakdown of the funding changes are as follows:
