

Central Florida Cares Health System, Inc.
Amendment #1 to Contract No. CAL23

THIS AMENDMENT entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **Community Assisted and Supported Living, Inc.** hereinafter referred to as the “Provider,” amends **Contract No. CAL23**.

The purpose of this amendment is to update the Subcontract, Attachment I, Attachment II, and Exhibit B, and introduce Exhibit C to align with contractual requirements. This amendment also aligns funding with the FY22-23 budget. A breakdown of the funding changes are as follows:

- **Mental Health Funding**
 - \$75,000.00 increase in MHCOM Mental Health Block Grant Supplemental Funding
 - \$77,813.00 increase in MHRES MH Residential Stability Coordination Supplemental 1 Funding
 - \$55,937.00 increase in MHRE2 MH Residential Stability Coordination Supplemental 2 Funding

All provisions not in conflict with this amendment are still in effect and are to be performed at the level specified in the contract.

This amendment and all its attachments are hereby made a part of the contract.
