

**Central Florida Cares Health System, Inc.  
Amendment #1 to Contract No. AVH23**

**THIS AMENDMENT**, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **Adventist Health System/Sunbelt, Inc. d/b/a AdventHealth Orlando**, hereinafter referred to as the “Provider,” amends **Contract No. AVH23**.

The purpose of this amendment is to align the budget with the FY20-21 funding allocations as shown below:

- Adult Substance Abuse
  - \$25,000.00 recurring increase in MSSM2
  - \$10,000.00 recurring increase in MSSGP
  - \$42,500.00 recurring increase in MSSM3
  - \$400,000.00 non-recurring increase in MSCS0

1. Page 1 is hereby amended to read (words underlined are inserted and words stricken are deleted):

 Local Match Requirement: \$0

2. Page 4 Section B Method of Payment is amended to read (words underlined are inserted and words stricken are deleted):

This is a fee-for-service rate contract, with the exception of GPRA OCA MSSGP which will be paid via cost reimbursement. The contract will be paid on a cost-reimbursement basis for the first three months (~~July, August and September 2020~~ November 2020, December 2020 and January 2021) during program implementation and ramp-up.

3. Pages 4-5 are hereby amended to read (words underlined are inserted and words stricken are deleted):

5. At the beginning of each fiscal year, the total subcontract amount in **Table 1** will be adjusted accordingly.
