

**Central Florida Cares Health System, Inc.
Amendment #1 to Contract No. AHP22**

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **Aspire Health Partners, Inc.**, hereinafter referred to as the “Provider,” amends **Contract No. AHP22**.
