

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **Osceola Mental Health, Inc. d/b/a Park Place Behavioral Health Care** hereinafter referred to as the “Provider,” amends **Contract No. PPB22**.

The purpose of this amendment is to update the Subcontract, Attachment I, Exhibit A and Exhibit B, and add Exhibit C and Exhibit D to align with contractual requirements. Additionally, to increase MHAPG funding, add MHCME, MS920, MSSM2 and MSSOH funding, and decrease MHA00, MHA72, MH0CN, MS000, MS0CN and MSSOR funding as shown in the table below:
