

**Central Florida Cares Health System, Inc.

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **The Children’s Home Society of Florida, Inc.** hereinafter referred to as the “Provider,” amends **Contract No. CHS24**.

The purpose of this amendment is to align funding with the FY22-23 budget by as shown below:

 - \$383,000.00 recurring increase in MH000 General Revenue (Wrap Around) Funding
 - \$154,747.00 non-recurring increase in MHHII Hurricane Ian Crisis Counseling ISP Funding
 - \$540,000.00 non-recurring increase in MHRSP Hurricane Ian Crisis Counseling RSP Funding
