

**Central Florida Cares Health System, Inc.
Amendment #2 to Rate Agreement No. HSP26**

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS” and **The Children’s Place at Home Safe, Inc. D/B/A Home Safe** hereinafter referred to as the “Provider,” amends **Rate Agreement No. HSP26**.

The purpose of this amendment is to update the rate agreement amount, ending date and number of days funded by CFCHS, as shown below.

1. Page 1 is hereby amended to read (words underlined are inserted and words stricken are deleted):

2. Page 4 is hereby amended to read (words underlined are inserted and words stricken are deleted):

2. Contractor will reimburse the Subcontractor for services using the rate negotiated between the Subcontractor and their respective Managing Entity as follows:

Level of Care: Room and Board Level II - STGH

Day rate from contract execution through 6/30/2025: \$298.84

Day rate effective 7/1/2025: \$344.97

Number of days funded: ~~468~~ 334 Days

Total Funded Amount: ~~\$172,430.68~~ \$106,455.28

This amendment shall begin on **10/8/2025** or the date in which the amendment has been signed by both parties, whichever is earlier.

All provisions in the contract and any attachments thereto in conflict with this amendment shall be and are hereby changed to conform to this amendment.

All provisions not in conflict with this amendment are still in effect and are to be performed at the level specified in the contract.

This amendment and all its attachments are hereby made a part of the contract.
