

Central Florida Cares Health System, Inc.
Amendment #5 to Contract No. STE26

THIS AMENDMENT, entered into between **Central Florida Cares Health System, Inc.**, hereinafter referred to as “CFCHS”, and **Specialized Treatment, Education and Prevention Services, Inc.**, hereinafter referred to as the “Provider,” amends **Contract No. STE26**.
